Hello Jeffery and planning group,

First and foremost, thank for the work you are doing on this important issue. I have filled out the survey and wish to add some thoughts.

Most if not all of the proposed work focuses on Hemlock, which is understandable. There are two issues that I think should be added:

1) How to successfully and efficiently regulate traffic speed on Hemlock. Cars currently are speeding by, causing stress to those walking on the "sidewalks".

Just the other day a car came zooming by and with a distracted driver no less, the car veered off the road and we and the dogs had to jump into the bushes to be safe.

2) There are "danger zones" that should be addressed on additional residential streets.

Case in point, and very self serving, is the traffic of visitors and staff leaving Ocean Lodge (and to some degree, Stephanie Inn) who turn left onto Chisana at full speed and above.

We have twice almost been hit a few times.

Making matters worse is the big storage container that is blocking the view from drivers making the left hand turn.

Insuring that our main street is safe and easy to navigate is great. Let's not forget the other streets and issues that need attention as well, even if only to make locals have added safety and peace of mind.
